## Annual Report for the Development and Structure Section, 2020

- 1. We are planning to award Cheadle Student Travel Awards and Sectional Student Travel Awards of \$50 each to offset the cost of registration for student members attending the virtual Botany 2020 meeting. We plan to acquire a list of the students that checked the following two categories (listed below) during the abstract submission to determine which students are eligible for and will receive these awards. Since the awards will be smaller than previous years, due to decreased costs with the virtual meeting, we plan to give out awards to every student who places their abstract in either the category of *Anatomy and Morphology* or *Evo-Devo*.
- 2. The program director (Lena Hileman) reported that Botany 2020 will have a total of 22 posters and 30 contributed papers from the Development and Structure Section. Of these 11 posters and 16 papers are Anatomy and Morphology and 11 posters and 14 papers are Evo-Devo. We sponsored two colloquia for Botany 2020: "Characteristics of nectar, nectaries, and nectar spurs," and "The Science of Meaningful Undergraduate Research Experiences."
- 3. The financial shape of the section is consistent with the previous year, which is sound (reporting covering 1 Oct 2018 13 July 2020). Membership increased to 251 current members, from 228 in the previous year. At the end of the 2018-2019 financial year, we had a sectional cash balance of \$56,342. As a result of a generous gift for student travel awards, the balance to date (13 July 2020) is \$69,579. Additional financial information is detailed in the table below.
