Annual Report for the Developmental and Structural Section, 2022

- 3. The 2022 Kaplan Dissertation Award was given to Yesenia Madrigal Bedoya from the University of Antioquia in Colombia, mentored by Natalia Pabon-Mora for her work on "A Morpho-anatomical characterization of the vegetative-to-reproductive meristematic transition in terrestrial and epiphytic neotropical orchids."

- 4. The program director (Rob Baker) reported that Botany 2022 will have a total of 18 posters and 36 contributed papers from the Developmental and Structural Section. We no longer define contributions into "Anatomy/Morphology" and "Evo-Devo" categories, but instead abstracts are submitted to the Developmental and Structural Section at large. We sponsored two symposia: (*Tackling coloniality in plant sciences: Legacies and paths forward & Black Botanical Legacy: Fostering a Community of Equity in Botanical Sciences*) and one colloquium (*Innovation and Novelty in the Evolution of Plants*) for Botany 2022.
- 5. The financial shape of the section is consistent with the previous year, which is sound, although the value of investments is still being calculated. Certainly some of the gains during 2021 have been reduced this year. Membership increased from 296 the previous year to 299 current members who have Developmental and Structural Sectional Affiliation. At the end of the 2020-2021 financial year, we had a sectional cash balance of \$70,947. The balance to date (29 June 2022) is \$87,553 in D&S sectional accounts and \$33,403 in the Cheadle account.
